Open Positions & Responsibilities

Treasurer: The Treasurer shall have charge and custody of and be responsible for all funds and/or securities of the organization, receive/give receipts for money due and payable to the organization, from any source, and deposit all such monies in the name of the organization in such banks, as selected by the Board and in general perform all duties incident to the office of Treasurer. Also, render a statement of the account at each meeting and then make them available to the Board. The position of Treasurer can be a 1 year term position and not to exceed 3 consecutive terms. This is a voting position.
